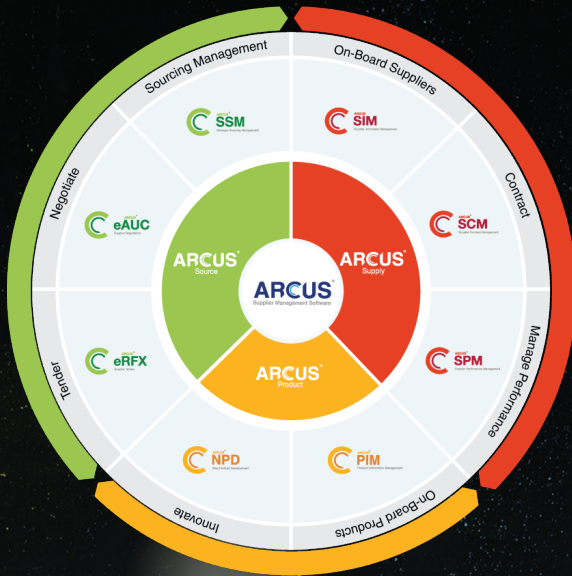
Palm oil from Malaysia, Indonesia and Sierra Leone has been highlighted by the US Department of Labor amongst other organisations on the 'Goods produced by Child labour or forced labour' list. As well as this, prawns supplied from Thailand, Bangladesh and Myanmar are also highlighted in the report. Over 25 million people are estimated to be subject to modern slavery globally.



Monitoring the supply chain is often difficult but cannot be ignored.
